



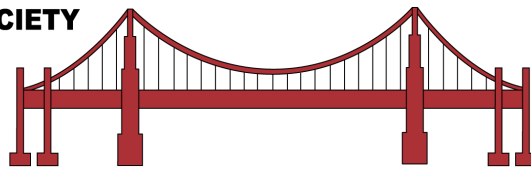

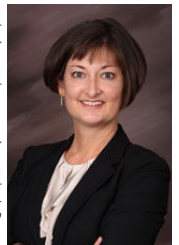

## Cal/OSHA Update: What to Watch for in 2018

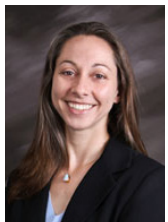


**Fred Walter:** Named by Cal/OSHA Reporter as one of the “Most Influential” people on the Cal/OSHA scene, Mr. Walter has represented employers in California and other states in OSHA compliance matters and “serious & willful misconduct” claims since 1985. He is admitted to practice in all California courts, the Ninth Circuit Court of Appeals and the U.S. Supreme Court. Fred leads the firm’s crisis management practice, providing clients with legal advice and representation during and after critical events. His article, “Crisis Management: The Legal Perspective”, was published in the March 2003 edition of Safety Professional. Fred is often invited to talk on topics related to workplace safety for the firm’s clients, public agencies and professional organizations. He is co-author, with his partner, Lisa Prince, of the “Workplace Safety” chapter of the California State Bar publication, *Advising California Employers and Employees*.
