Deep Creek Road Pedestrian Crossing Improvements (PWC 8698) - The project would install traffic calming devices on Deep Creek Road at the intersections of Macbeth Avenue and Emilia Lane. The work involves construction of intersection bulb-outs, curb ramps, speed tables/raised crosswalks, raised medians, striping and signing and any other items not mentioned above that are required by the plans. Engineer's Estimate is \$305,000. Anticipated bid opening is May/June 2012. Paseo Padre Parkway Electrolier Replacement Project - Walnut Avenue to Washington Boulevard (PWC8756) - The work consists of removal of the concrete marbelite electroliers, installation of city standard electroliers, signing and other items required by the plans. Engineer's Estimate is \$100,000. Anticipated bid opening is May 2012. Niles Boulevard Parking Lot Site Improvement Project - City Lots 1 and 2 (PWC8700P) - The work consists of installation of asphalt concrete, retaining curbs, slurry seal, storm drain modifications, landscaping, irrigation, lighting, striping and other items required by the plans. Engineer's Estimate is \$275,000. Anticipated bid opening is May 2012. Development Center Seismic Upgrade, HVAC Replacement, and Exterior Wall Repair (PWC 8752) - The project consists of voluntary partial seismic retrofit, replacement of two existing 40-ton HVAC rooftop units, and repair exterior brick wall tiles. This project also includes work to provide epoxy roof coating to existing roofing. Engineer's Estimate is \$950,000. Anticipated bid opening May 2012. Exterior Wall Tile, Sealant, & Grout Repair at Fremont Main Library (PWC 8393) - The project consists of partial removal and replacement of exterior wall tiles, sealant, and grout and tune-up of window and storefront systems. This project also includes work to provide new sheetmetal caps at three concrete porticos. Engineer's Estimate is \$200,000. Anticipated bid opening in May, 2012. Uninterruptible Power Supplies (UPS) Upgrade for Police Dept. Dispatch Center & Server Room (PWC 8649)- The project involves the replacement of two existing uninterruptible power supplies (UPS) systems (one 15kVA and the other 40kVA) at the Equipment Room on the third floor of

the Police Department Building, serving the dispatch center and server room. The size of the new system is 48 kVA. Engineer's Estimate is \$100,000. Anticipated bid opening in May, 2012. Niles Boulevard Roadway Improvement between Hillview Drive to the Sullivan Underpass (PWC8666) - The project includes the following items of work: clearing, grubbing, roadway excavation, and removal of concrete improvements; installation of asphalt concrete pavement; concrete curbs, gutters, sidewalks, and driveways; modifications to storm drain system and street lighting; placement of signing and striping; minor landscaping and any other such items or details that are required by the plans, standard specifications, and special provisions. Engineer's Estimate is \$1,600,000. Anticipated bid opening is May 2012. Replace wall coverings and carpet at the Fremont Police Buildings (PWC 8649) - The project consists of the replacement of wall coverings and carpet throughout the building at the Fremont Police Building. Karl Nordvik Synthetic Turf Conversion (PWC8577) - The improvements include the demolition of the existing ballfield, fencing and lighting and surrounding concrete, rough grading, import of fill material, fine grading, improvements to existing drainage systems, demolition and modification of the irrigation system, irrigation and planting, chain link fencing and gates, mow band, concrete paving and pathway, coordination of the installation of synthetic turf, dugout benches, foul poles, drinking fountains, sports field lighting and electrical, the addition of new parking lot lighting, construction of a new 28 space parking lot, biotreatment measures, and other such items or details that are required by Plans, Standard Specifications and these special provisions. Engineer's Estimate is \$1,800,000. Anticipated bid in June 2012. HVAC Unit Replacement at Fremont Main Library (PWC 8754) - The project involves replacement of seven 40-ton HVAC units on the roof. Works consists of removal of existing VAV air-conditioning units and the integrated roof screen system and installation of new units and new roof screen system. Engineer's Estimate is \$900,000. Skate Park (PWC8672) - The one acre site improvements include the demolition of the existing fence, rough grading, fine grading, improvements to existing drainage systems, demolition and modification of the irrigation system, new irrigation and planting, chain link fencing, 25,000 square foot cast in place concrete skate surface with bowls and raised features, walls, shade structure, picnic tables, benches, synthetic turf, bioretention planters and stormwater treatment measures, and other such items or details that are required by Plans, Standard Specifications and

2012 Cape and Slurry Seal Project (PWC8195-D) - The Project is more specifically defined in the Contract Documents, but generally includes the following items of work: The work to be performed consists of applying cape seals and slurry seals on various streets including providing advance public notification on all project streets; maintaining traffic and furnishing traffic control throughout construction; preparation of roadways to receive surface treatment including removal of thermoplastic and painted striping and markings and removal of raised pavement markers; applying asphalt rubber chip seal and micro seal to selected streets; applying polymer modified slurry seal to selected streets; and the replacement of raised pavement markers and pavement striping and markings. There may be other items of work not mentioned above that are required by the State Standard Specifications or the Special Provisions. Engineer's estimate is \$3,000,000. Central Park Softball Complex Light Replacement: The improvements include the removal of all existing sports lighting luminaires, remove all mercury floodlights on poles 20 feet above grade, remove all wiring back to hand hole at base of poles. Install new remote ballast, provide new wiring through pole, install new sports lighting luminaires, install additional lighting fixtures, provide commissioning for lighting system to ensure aiming and photometric coverage, and other such items or details that are required by Plans, Standard Specifications and these special provisions. Add alternate work shall include remove wiring and components associated with control of existing sports lighting located in the existing switchboard, install new lighting control, and install wireless controls and related hardware. Engineer's Estimate is \$350,000, not including alternate work. Anticipated bid in April 2012.
