All courses will require user authentication at the beginning of the course and then randomly each hour until course completion. Test and quiz sections must provide feedback for any incorrect answers with the correct answer shown, detailed descriptions, and contextual explanation of the correct answer. All OSHA courses must also now be purchased through an OSHA-authorized training provider.

“We look forward to continuing to be a leader in providing high quality online safety training and releasing our other authorized courses in the coming months,” said Tonry.

OSHA authorized [ClickSafety](#) to deliver the [10-hour](#) Construction, General Industry, California-specific and Road Builder course in both English and [Spanish](#) languages and [30-hour OSHA](#) for Construction and General Industry.
