2012 Base Repair Project (PWC 8234-M) - The Project is more specifically defined in the Contract Documents, but generally includes the following items of work: The work to be performed consists of maintaining traffic and furnishing traffic control throughout construction; grinding and removing failed pavement areas and installing deep lift hot mix asphalt sections and the replacement of raised pavement markers, pavement striping and markings and detector loops. There may be other items of work not mentioned above that are required by the State Standard Specifications or the Special Provisions. Engineer's estimate is \$1,500,000. Deep Creek Road Pedestrian Crossing Improvements (PWC 8698) - The project would install traffic calming devices on Deep Creek Road at the intersections of Macbeth Avenue and Emilia Lane. The work involves construction of intersection bulb-outs, curb ramps, speed tables/raised crosswalks, raised medians, striping and signing and any other items not mentioned above that are required by the plans. Karl Nordvik Synthetic Turf Conversion (PWC8577) - The improvements include the demolition of the existing ball field, fencing and lighting and surrounding concrete, rough grading, import of fill material, fine grading, improvements to existing drainage systems, demolition and modification of the irrigation system, irrigation and planting, chain link fencing and gates, mow band, concrete paving and pathway, coordination of the installation of synthetic turf, dugout benches, foul poles, drinking fountains, sports field lighting and electrical, the addition of new parking lot lighting, construction of a new 28 space parking lot, bio treatment measures, and other such items or details that are required by Plans, Standard Specifications and these special provisions. Niles Boulevard Parking Lot Site Improvement Project - City Lots 1 and 2 (PWC8700P) - The work consists of installation of asphalt concrete, retaining curbs, slurry seal, storm drain modifications, landscaping, irrigation, lighting, striping and other items required by the plans. Exterior Wall Tile, Sealant, & Grout Repair at Fremont Main Library (PWC 8393) - The project consists of partial removal and replacement of exterior wall tiles, sealant, and grout and tune-up of window and storefront systems. This project also includes work to provide new sheet metal caps at three concrete porticos. Engineer's Estimate is \$200,000. Anticipated bid opening in June 2012. Development Center Seismic Upgrade, HVAC Replacement, and Exterior Wall Repair (PWC 8752) - The project consists of voluntary partial seismic retrofit, replacement of two existing 40- ton HVAC rooftop units, and repair exterior brick wall tiles. This project also includes work to

PWC8767-Irrigation Controller replacement for Park System: The improvements include the replacement of all existing irrigation controllers and other related components of the irrigation systems, with a Calsense automatic system in 9 community parks (Central Park, Centerville, Irvington, Los Cerritos, Mission San Jose, Niles, Northgate, Sylvester Harvey, Warm Springs) and 6 neighborhood parks (Arroyo Agua, Booster, Frank Fisher, Lone Tree, Old Mission, Rix). Work includes installation of flow sensors, master valves, trenching, or boring, for dedicated conduit, hubs and antenna, electrical connections, low voltage wiring connections, miscellaneous concrete and asphalt repair. Replace wall coverings at the Fremont Police Buildings (PWC 8649) - The project consists of the replacement of wall coverings throughout the building at the Fremont Police Building. Patterson House Rehabilitation (PWC 8766) - This project is a rehabilitation of the Patterson House located at historic Ardenwood Farm. Project scope includes foundation and structural upgrade, new mechanical system, replacement of electrical system wiring/equipment and associated architectural finishes stabilization and rehabilitation. Signal Modification Project at Walnut Avenue and Gallaudet Drive/Cherry Lane (PWC 8763) - The project entails a modification of the traffic signal phasing on Gallaudet Drive/Cherry Lane at Walnut Avenue, an upgrade of the safety lighting to LEDs, removal of the east side crosswalk with associated striping, and replacement of some vehicle detector loops. Speed Lumps on Streets in Front of Schools (PWC 8762) - The project consists of installing 2 to 4 speed lumps and related signing and striping on Emilia Lane (Ardenwood Elementary), Maybird Circle (Forest Park Elementary), Darwin Drive (Warwick Elementary), School Street (Niles Elementary), Sundale Drive (Brier Elementary), and South Grimmer Boulevard (Weibel Elementary).
