Karl Nordvik Synthetic Turf Conversion (PWC8577) - The improvements include the demolition of the existing ballfield, fencing and lighting and surrounding concrete, rough grading, import of fill material, fine grading, improvements to existing drainage systems, demolition and modification of the irrigation system, irrigation and planting, chain link fencing and gates, mow band, concrete paving and pathway, coordination of the installation of synthetic turf, dugout benches, foul poles, drinking fountains, sports field lighting and electrical, the addition of new parking lot lighting, construction of a new 28 space parking lot, biotreatment measures, and other such items or details that are required by Plans, Standard Specifications and these special provisions. Replace Fire Alarm System at the Fremont Police Building (PWC 8649) - The project consists of the replacement of the fire alarm panel and all required components at the Fremont Police Building. - Phase II Beacon Avenue, California Street and Walnut Avenue Frontage Improvements, City Project No. 8749 (PWC), Federal Project No. CML-5322(051). The Project is more specifically defined in the Contract Documents, but generally includes the following items of work: Furnishing and maintaining traffic control and pavement delineation throughout the period of construction; maintaining pedestrian barricades and detouring pedestrian traffic around the work area; saw cutting, demolishing and disposing of existing improvements including asphalt pavement and berm and PCC curb and gutter, median curb and gutter, driveway and field inlet; installing new storm drain inlet, trash capture inlet and tops on existing inlets; earthwork including on-site cut to fill and export of excess soil and aggregate base materials to make subgrade for all new concrete construction; trenching and installing street light conduit and irrigation system and appurtenances; installing new PCC curb and gutter, median curb and gutter, sidewalk, traffic island, curb ramps and driveway; installing hot mix asphalt patches fronting concrete; installing street light system and street furnishings; installing plantings, trees and tree grates; lowering utilities and

installing pavement base repairs and grinding and overlaying fronting streets; installing traffic signs, striping and pavement marking sand raising utilities to final pavement elevation. There may be other items of work not mentioned above that are required by the State Standard Specifications or the Special Provisions. Engineer's Estimate is \$1,750,000.00. Measure WW Well Irrigation Well and Pump Replacement (PWC8768) - This project consists of the rehabilitation/replacement of 4 irrigation well pumps and the upgrade of the electrical systems at Centerville Community Park, Central Park at Animal Shelter, Central Park at Babbling Brook, and Niles Community Park. (PWC 8739) - Three separate picnic areas in Central Park are to be renovated. Improvements include rough and fine grading; minor demolition; the installation of ADA compliant paving and sidewalks; rehabilitation of shoreline along Lake Elizabeth; tree and landscape planting; connection to existing irrigation systems; installation of picnic tables, preparation tables, barbeque pits, other decorative hardscape elements; and other such items or details required by the Plans, Standard Specifications, and Special Provisions. Engineer's Estimate is
