Warm Springs Community Park Restroom and Meeting Room Replacement – (PWC 8777) – The Project general description for consists of demolition of the existing meeting room and restroom, site grading and utility connections (sewer, potable, electrical, fire) construction and installation of two pre-fabricated structures, new landscaping and new irrigation, and site drainage. Central Park "Always Dream" Restroom Replacement at Fabbri Field— (PWC 8718) – The Project general description for consists of demolition of the existing restroom, site grading and utility connections (sewer, potable, electrical, fire) construction and installation of a pre-fabricated bathroom structure, new landscaping and new irrigation, and site drainage. The Engineer's Estimate for base bid work is \$552,000. **Anticipated bid opening is February 2016**. 2016 Pavement Rehabilitation Project – (PWC 8234-P) - The improvements to be constructed, in general, consist of: Furnishing and maintaining traffic control throughout construction; removing asphalt concrete roadway surfacing by excavating and cold planning, performing full-depth hot mix asphalt base repairs of various depths, placing of hot mix asphalt leveling course, replacing traffic signal detector loops and related facilities, placing hot mix asphalt overlays, adjusting utility facilities, including lowering prior to grinding and raising to finish grade after overlay; installing signs, applying thermoplastic traffic stripes and pavement markings and placing reflective pavement markers. There may be other items of work not mentioned above that are required by the State Standard Specifications or the Special Provisions. 2016 Cape and Slurry Seal Project (PWC 8195-L) - The project consists of applying cape seals and slurry seals, delivering advance public notifications; implementing traffic controls, removing weeds from the roadway, pruning of trees; removing and replacing traffic striping, markings, and raised pavement markers; installing roadside signs, and other associated work. Old Canyon Road Bridge Foundation Protection Repair Project (PWC 8805) - The project involves scour countermeasures work consisting of implementing traffic controls, removing undercut and/or deteriorated grouted rock riprap in the channel below the Old Canyon Road Bridge (Stanley Harding Bridge), dewatering, excavation of existing material, placement of filter fabric and rock riprap, backfilling and grading, placement of erosion controls, broadcast seeding, and biological monitoring.
